North Georgia Chapter, Studebaker Drivers Club
Meeting Minutes
October 4, 2009

- President Dan Miller opened the meeting. We had an excellent turnout today: 49 members and guests with 15 Studebakers and Avantis. Thank you to Ben and Janet Alspach for hosting us at the Kennesaw train depot. Ben had passes to the Southern Museum of Civil War and Locomotive History, for those who wish to come back and take a tour. Dan pointed out the new Studebaker sign which Jim Fisher made for us to display at our meetings.
- Announced birthdays, anniversaries, and those members we need to keep in our thoughts and prayers. We remembered our long-time friend and chapter member John Brown, who passed away on September 23 after battling leukemia for several years. Chuck Lampman is assisting Dorothy Brown in cataloging and establishing prices for John's collection of Studebakers and parts.
- Maureen Elliott thanked everyone in the chapter for all the support given to her and Tom, and in particular for the response to the ALS walk/fundraiser being held Saturday November 14th. A stem cell treatment research trial has just been approved, with plans to have 12 participants in this test to see how well patients accept the transfer of cells into the spine. Since Tom's doctor is one of those participating in this initial release, we are in hopes that Tom can be one of the initial 12. Once success in delivering the treatment and a patient's ability to tolerate it are confirmed, subsequent trials will be done with more people to evaluate the effectiveness of this approach as a way to arrest the progress of ALS.
- Ed Burris is heading to Jacksonville this afternoon in order to attend tomorrow's services for Nollie Hinton, a SDC member in North Florida who passed away on October 1st.
- Wayne Lee mentioned that nominations are being taken for the SDC Southeast Zone Coordinator position. Nominations should be submitted to Richard Dormois; you can get Richard's contact information from Chris Collins
- We made more progress on next year's meeting calendar. We would like to get this finalized by the November meeting, so we can meet the lead times for timely inclusion in *Turning Wheels*. Here is what we have so far:

- We also need to decide if we want to sponsor the 2010 Zone Meet on a joint basis with the Heart of Dixie Chapter in Alabama, as outlined in the October *Hillholder*. We will vote on this proposal in December, when we typically have the most members present. Wayne's contact with the Alabama chapter indicated that their group has not been very active this summer, so the joint meet proposal is still being floated there as well.
- Tom Elliott related the adventure he and an equally determined Matthew Burnette had in getting Tom's 1951 Starlight coupe operating. For the first time in about 35 years, they did get it running and on the road for an extended test drive. Mud daubers in the fuel line turned out to be the culprit.
- Charlotte Delli presented the Treasurer's Report; a copy will be in *The Hillholder*. We now have approximately 63 memberships. An early reminder: dues for 2010 need to be in to Charlotte by December 31st; she will start collecting them at the Christmas party.
- Lenny and Phyllis Major have on hand two Medium club shirts, around eight Large ones and about ten Extra-Large. Motion made, seconded, and approved to order five Small and two additional Medium shirts to replenish those sizes.
- Chris reviewed the proposed changes to the chapter By-Laws, as summarized in the October *Hillholder*. The first revision clarified our membership definition to have one class of member, as SDC National does in its By-Laws. The second change was to allow the Membership Secretary, Secretary, and Treasurer to serve up to four consecutive one-year terms, up from the current two terms. Both amendments passed by unanimous vote of the members present. We will publish the revised By-Laws in their entirety in the January 2010 issue of *The Hillholder*.
- Nominations for our 2010 slate of officers are now open. Nominations need to be finalized at the November 1st meeting, so we can publish the candidates in the December newsletter, and vote on December 6. A nomination form will be in *the Hillholder*.
- We then drew for door prizes contributed by our hosts Ben and Janet. Winners were Bill Cope, Wayne Lee, and Barbara Miller. Lenny & Phyllis Major won the 50/50 drawing, and will split the \$95 pot with the chapter.
- Our November meeting will be at Bay Creek Community House in Loganville. This is the same location we used for our November 2008 meeting. Details will be in *The Hillholder*. Lenny and Phyllis Major ask that you let them know you are coming by Friday October 30.
- There being no further business, the meeting was adjourned. See you next month in Loganville!





This is a 99 page book based on the articles of the same name that appeared in *Turning Wheels* in the early 1990s and which won the SDC's Churchill Award for Best Article, Non-Paid. The book contains all the material from the original series, which ran for a year and a half in *The Hillholder*, and not only replaces some material edited out for the *TW* series, but has updates and several new items that were written after the *TW* series was published.

"Some Thoughts" is aimed at the first-time restorer, but will be of value to the more experienced; it doesn't try to be a "how to restore a car book", but gives you a look at the decision-making processes, tools, spaces and basic skills you'll need to do a restoration, and will provide a framework to help you structure your project.

There are several chapters of Studebaker-specific advice. In the chapter devoted to engine rebuilding, I've tried to describe a step-by-step process that anybody can follow, and I've tried to include tips I've picked up in building 60+ engines. I've received many compliments on the engine chapter, and I'm glad to finally be able to get it in print.
