



## James Robert Cade

### 1927 – 2007

Many of us know of James Robert Cade as the inventor of Gatorade and as a fellow Studebaker enthusiast. While true as far as that goes, there is a great deal more to learn about this gentleman. In 2002, Dr. Cade wrote an autobiography, *Freut Euch Des Lebens* (Find joy in your life).

In his autobiography, we see that Dr. Cade was a true Renaissance man; someone with broad interests that he pursued with depth and passion. We learn of his appreciation for the classics: literature, poetry, music. He was a man of science, yet with a strong spiritual dimension to his life. He applied his gifts not just in the technical aspects of his profession, but also to better understand people and what moves them. Reading this book provides glimpses into his childhood, naval service and college, marriage, travels abroad, and his work as a nephrologist. This experience with renal (kidney) function and diseases, along with a chance question from a football coach, led to the creation of Gatorade.

The following chapter from his work has our favored automobile marque in a supporting role.

### Teaching Terry To Drive

Terry Perinich was a pretty, funny, 22 year old girl who, armed with a brand new degree in medical technology came to Cornell, where I was working as a post doctoral research fellow, in the spring of 1959. She immediately became a part of our research group.

I had just accepted a position at a medical school in a far away little town called Gainesville in the wilds of Florida. I was to go there, take care of patients with kidney disease, teach medical students, interns and residents how kidneys work when healthy and when diseased, and in my spare time do research in renal physiology and new ways to treat patients with kidney disease. I would have my own laboratory and I would need a good laboratory technician to work with me, so I hired Terry. We arrived in Gainesville on July 4, 1961, set up my lab and began working. Everything went very well; the lab was beautiful and well equipped, we were doing good research. The students, interns, residents and I got along well. Mary and our four walking, talking small children liked Gainesville, and our brand new baby girl who was born a month after we reached Gainesville, was a delight. Things couldn't have been better, except Terry not only didn't have a car, she didn't know how to drive. She was an expert at subway riding but soon learned that was not a skill highly prized or useful in Gainesville, so....I volunteered to teach her how to drive.

Before I go any further, I have to tell you about Ol' Spot. Ol' Spot was a 1951 Studebaker two door sedan I bought after church one Sunday for \$10.00. That afternoon, I took the front plate off of our station wagon, put it on the rear of Ol' Spot and took off for Chicago where I was to present a paper at a big physiology meeting. She was beautiful--- had a new,

never used spare tire, a five gallon can of oil and a new chamois skin in the trunk; she ran great and went down the road as smoothly as a Rolls Royce. I didn't know why her previous owner had that five gallon can of oil, but thought it really nice of him to throw it into the deal for free.


It was a cold March day, low grey clouds scudding by when I drove out on New Jersey Route 22, the first leg of my journey. I had gone almost a hundred miles with no trouble, the heater worked well and I was extremely happy with my new acquisition. I'd noticed a little earlier that Ol' Spot ran a little warm, which was fine as it was a cold March day. Then I noticed the oil pressure was a bit low, so I stopped to see how much oil was in the crankcase and found it was two quarts low. I filled it, but found about another hundred miles down the road that the oil pressure was again low and a check showed it was again two quarts low. I learned over the next two hundred miles that Ol' Spot got 26 miles per gallon of gas, 40 miles per quart of oil, and 200 miles per radiator full of water. I also found that when a car was tailgating us I could put a huge cloud of bluish-black smoke between us and the tailgater, who when the cloud cleared was far behind us. He frequently came flying by us a few minutes later shaking his fist and yelling at us, words I couldn't understand with the window up, but he never tailgated us again. You may wonder how Ol' Spot got her name. I bestowed the name on her because of the oil spots she left to mark our path.

Now, back to Terry and solving her problem of getting around Gainesville. One afternoon we had finished the days work early, so I suggested we go out and I would give her a driving lesson. We, or I, drove out on Newberry Road until we were well out in the country and stopped at the top of a big hill, which, unlike everything else in Gainesville at the time, is still there. We changed places, and I explained again about letting the clutch out slowly and stepping on the gas when she felt the clutch engage. She did very well and left only a moderate cloud of blue-black smoke. Encouraged, we stopped after about a quarter mile and repeated the operation again with a slightly larger cloud of smoke. We did that several times and then when the cloud of smoke cleared we saw a police car with its lights flashing and coming up fast. I told Terry he wasn't after us because we had never gone above 35 miles per hour. After about a mile, he passed us, lights still flashing and motioned for us to pull over. We stopped; he came walking back to the car and asked to see Terry's driver's license. She didn't have one, so he asked to see mine. Then he walked back to his car and told the dispatcher that a fat guy was teaching his daughter how to drive, that we were weaving down the road and she didn't have a driver's license. At that time I wasn't really fat and we hadn't been weaving down the road. Although I was greatly offended by his statements, I thought it was probably wise to say nothing. He gave both of us tickets - - - Terry for driving without a license, and me for contributing to the delinquency of a minor, another egregious offense.

The judge, when we saw him two weeks later, fined me \$10.00 and gave both of us a lecture about obeying Florida's laws. The really sobering part of his sentence, however, was ordering us to attend a class for safe driving every Tuesday night for six weeks. The only thing we learned from the movies and the lectures they presented was that speeding and drunk driving were bad, bad, bad and killed people. As both of us knew that already and we weren't guilty of either offense, I considered the class a total waste of time. Terry, however, enjoyed the questions and comments of the southern rednecks.

Terry, under my tutelage and with assistance from her roommate who had a car with automatic transmission, learned to drive and now, 36 years later, has never again been arrested for driving without a license. I have never again been arrested for contributing to the delinquency of a minor. Ol' Spot is still a cherished member of our family, and no policeman has ever stopped her again for weaving down the road.

Reflecting on those three facts as I wrote, it occurred to me that perhaps all three of us had learned something valuable from our experience.

### History of Studebaker

(source: 1966 Model Year Introduction Press Kit)

- 1935: The company came out of receivership and Paul G. Hoffman was named president with Harold S. Vance chairman of the board. The Studebaker Pacific Corporation, Los Angeles, California, a wholly-owned subsidiary of the Studebaker Corporation, started assembly of passenger cars. First overdrive transmission introduced. First to produce a six-passenger sedan.
- 1937: First to use variable steering gear.
- 1939: Champion series introduced as the company re-entered the low price field.
- 1942- During World War II, Studebaker produced 63,789 Wright-Cyclone aircraft engines, 290,000 military trucks, and 15,000 amphibious cargo carriers (Weasels), for a war production total of \$1,200,000,000.
- 1945: Chippewa plant built by the government in 1942 for assembly of B-17 bomber engines, purchased from the government by Studebaker for truck assembly operations.


Take the Hamilton Mill Rd NE exit 120 - go 0.2 miles,



STUDEBAKER MEDIA

I finally finished it! This is a 99 page book I've put together based on the articles of the same name that appeared in *Turning Wheels* in the early 1990s and which won the SDC's Churchill Award for Best Article, Non-Paid. The book contains all the material from the original series, which ran for a year and a half in *The Hillholder*, and not only replaces some material edited out for the *TW* series, but has updates and several new items that were written after the *TW* series was published.



"Some Thoughts" is aimed at the first-time restorer, but will be of value to the more experienced; it doesn't try to be a "how to restore a car book", but gives you a look at the decision-making processes, tools, spaces and basic skills you'll need to do a restoration, and will provide a framework to help you structure your project.

There are several chapters of Studebaker-specific advice. In the chapter devoted to engine rebuilding, I've tried to describe a step-by-step process that anybody can follow, and included tips I've picked up in building 60+ engines. I've received many compliments on the engine chapter, and I'm glad to finally be able to get it in print.


